School News

- We hope very much that this finds you all safe and well. We are truly sorry that we have had to temporarily close only days into this new half term, however, the safety of our school community is paramount. Closing is always a last resort, but the decision was made in collaboration with the LEA, Public Health England and school governors. We were reassured by the LEA that the systems we have implemented, and actions taken are exactly in line with all the guidance. By creating four separate bubbles and following strict cleaning regimes, we have hopefully significantly lowered the risk of many of the children in school contracting Covid-19. A deep clean will take place while we are closed. We feel grateful that most of us had an undisrupted last half term during which time the children adapted extremely well to life in school. We are confident that they will all continue to do so once back in school in a couple of weeks.
- A huge thank you to all those parents who have been in touch with school to express their support and understanding. We have been overwhelmed by your kind words especially given the challenges many of you are facing yourselves. By working together, we will get through this!
- The teachers are regularly updating the Home Learning pages on the website with work and reassuring messages for the children. We would encourage all our children to have a go at what they can and to also watch the videos which are being uploaded by staff; but there is absolutely no pressure to do so. We will continue to work hard with each individual child to ensure their educational and mental health needs are met. If you are struggling with accessing the online resources, please do not hesitate to contact us.
- We have contacted all families who are eligible for benefits-related Free School Meals (FSM) to arrange food parcels for the duration of the school closure and isolation periods.
- We know that many are finding life incredibly tough. We are in unprecedented times and it is tricky for adults to manage their feelings never mind our children. Please do not suffer in silence. We will always help and support any family in need as best we can and there are lots agencies who can offer assistance. Please email us on the admin or head teacher email addresses if you need help. - As we all know, the new national 'Lockdown 2' restrictions come into force today. Please click on the link for guidance, including what they mean for working from home and business closures, and the financial support available. We strongly urge everyone to follow the guidelines for the safety of yourself and others. Of particular note is that parents are able to form a childcare bubble with another household for the purposes of informal childcare, where the child is 13 or under; some households will also be able to benefit from being in a support bubble, which allows single adult households to join another household; and it is not mandatory to wear face masks in early years settings during lockdown, however, it is up to the discretion of individuals. Bonfire Night

England enters a second lockdown on Bonfire Night, with major displays cancelled and strict rules about gatherings. Some people might still want to let off some rockets in their own back gardens but you must not meet inside or in your garden with family or friends, unless they are part of your household - that is, the people you live with – or a support bubble. Anyone caught in breach of lockdown rules on household mixing, even in a garden, could face a fine starting at £200. If you are found to be the organiser of a gathering of more than 30 people - such as a firework display for family and friends - you could face a fine of £10,000.

If you are still planning to go ahead with a fireworks display please follow the Firework Code:

- Only buy fireworks with a CE mark
- Don't drink alcohol if setting off fireworks
- Keep fireworks in a closed box
- Follow the instructions on each firework
- Light them at arm's length, using a taper
- Stand well back
- Never go near a firework that has been lit. Even if it hasn't gone off, it could still explode
- Never put fireworks in your pocket or throw them
- Direct rockets away from spectators
- Always supervise children around fireworks
- Light sparklers one at a time and wear gloves
- Never give sparklers to a child under five
- Keep pets indoors

• Don't let off fireworks after 11pm

Advice on bonfires

- Check for hedgehogs and other wildlife before lighting your bonfire.
- Never use paraffin or petrol on a bonfire.
- Don't build bonfires close to trees, hedges or sheds.
- Don't light a bonfire under an electricity cable
- Don't burn Fuel (e.g. Petrol, Diesel), Household rubbish (e.g. plastics), Aerosol cans, Lighter fluid, Tyres, Fireworks, Gas canisters, Foam, Paint, Anything wet
- Don't leave bonfires unattended.
- Make sure that the bonfire is out and surroundings are made safe before leaving.

Setting off fireworks in the street is a crime. You can report any offences to the police and the fire service.



Please take care, stay positive and find some time for having fun and smiling. It is a challenging time but we will get through this, together.
